- Supported the DOE Regulatory Reform Initiative on Safety and Health
- Worked with DOE on continued project and contract management improvement (Order 413.3B and Guides, EVMS, cost estimating, PARS II)
- Continued progress in understanding and closing gaps in human capital critical skill needs
- Conducted knowledge sharing and information exchange on energy efficiency initiatives and D&D execution
- Supported DOE in planning/executing ARRA projects
- Supported DOE in the update and revision of DOE Order 435.1,
 Radioactive Waste Management


