


BMWG Organization Chart

- Accomplishments:
 - Provided support to Carmelo Melendez, SPO & Director, Office of Property Management, in the Office of Acquisition & Project Management (MA-60)
 - BMWG provided input on the various approaches and databases in use across the complex to collect vehicle management data
 - BMWG sub-team developed a set of recommendations in response to DOE Order 205.1B, DOE Cyber Security Program, regarding how to develop and implement a Risk Management Framework process for cyber security
 - Report was shared with DOE-CIO

Planned:

Business Management Working Group Cyber Security Summary



- DOE Order 205.1B
 - Shift from compliance-based model to Risk Management Approach
 - Truly integrates cyber security into all aspects of business to secure information and information systems
 - Cost-effective and based on MISSION
- Implementation plan is strategic and is developed locally to support individual site mission
- Implementation of requirements coupled with resource constraints requires innovation and collaboration
 - Cyber Security as a Service
 - Enterprise Licensing
