CH2M HILL DOE Prime Contractor Projects

Hanford Central Plateau Remediation Site

Location: Hanford, Washington, USA

Value: \$5.7 billion

Project Scope

- Disposition of SNM, remediation, exhuming, and disposing of buried waste
- Decommissioning and Demolition of more than 800 facilities and structures
- 586-square mile Site is the U.S.'s largest environmental cleanup effort
- Remediation of contaminated environmental sites and groundwater

Our Role

- Prime contractor for the cleanup of hundreds of buildings and 1,200 waste sites
- Shrinking the Hanford Site cleanup area to less than 75 square miles by 2015 and further reduction to 10 square miles post-2015



Subcontracting at Hanford Central Plateau

- Since contract start in October 2008, \$2.08 billion has been subcontracted, with approximately 50 percent, or \$1.02 billion, in awards to more than 450 small businesses.
- \$40.1 million to small businesses in FY2013
- Expect to award similarly in FY2014



Subcontracting at Hanford Central Plateau

Big ticket items and general categories of smaller items that will be procured or subcontracted in 2014:

- Roof Repair for facilities in 100 Areas due to weather damage
- Conceptual Design Report for Waste Encapsulation and Storage Facility (WESF)
- Four 100 Area Boreholes
- Environmental support for Record of Decision (ROD), Closure Plans and Work Plans (support TPA negotiations)
- Environmental support for Treatability Test and Feasibility Study
- Fabrication activities for 1) resin vessels at 200W Pump & Treat, 2) ECRTS – Engineered Containers for Retrieval/Transfer Sludge systems.
- Well drilling, logging, soil barriers and injection of apatite solutions
- Several activities for construction forces assume we will use current SB contract for these.

Subcontracting at Hanford PRC – next 5 years

PRC's subcontracting strategy for the five-year option period contract

- Anticipated that this approach will save \$13 million per year that can be used to accomplish additional cleanup
- Certain contracts for work currently performed by approximately 30% of the subcontract workforce will be re-competed now through summer (e.g. Waste Mgt., Training and Procedures, Construction Management)
- Maintain current contracts for high-priority work functions (e.g. sludge program) and work functions requiring uniquely-qualified skill sets (e.g. nuclear safety and risk modeling),
 - approximately 15% of the subcontract workforce
- Approximately 55% of the subcontractor workforce invited to join CHPRC as we move from subcontracting long-term staff augmentation

Idaho Cleanup Project (ICP)

Location: Idaho Falls, Idaho, USA

Project Scope

The \$2.9 billion ICP-I was completed October 2012 - focused on reducing risks to workers, the public, and the environment and protecting the Snake River Plain Aquifer.

- Disposal and disposition of nuclear materials
- Management of spent nuclear fuel
- Closure of former high-level waste tanks
- Treatment and disposal of radioactive waste streams
- Cleanup of contaminated soil and water
- Demolition of high-risk and excess facilities
- Majority Partner



Idaho Cleanup Project (ICP-II)

- ICP-II contract runs 2013-2015 and includes
 - Sludge
 - Fuel Movements
 - Domestic receipts
 - CH TRU
 - IWTU
 - Tank closure
- Have not changed our strategy with regards to subcontracting during ICP-II contract
- Looking for suppliers who are sustainable, bio-based and environmentally friendly in order to meet sustainable requirements of contract



Subcontracting at Idaho Cleanup Project

- Subcontracted \$918 million through life of ICP-I contract, with nearly \$614 million, or 67 percent in awards to small business
- Since contract start of ICP-II in October 2012, we have subcontracted out nearly \$84 million, with \$38.6 million going to small business

Subcontracting Opportunities

Small Business Program & Subcontracting

- Far exceeding Department-wide goal of 10% of prime contracting dollars being awarded to small businesses
- CH2M HILL aggressively pursues subcontracting opportunities with small, disadvantaged, minority, veteran-owned, and woman-owned enterprises in the performance of its federal, state, commercial, industrial, and municipal contracts.

- 1. Register your business in the Federal Contractor Registry (SAM) database. <http://federalcontractorregistry.com/>**
 - ◆ Ensure all fields are populated; key words, capabilities, references
 - ◆ Update profile frequently
- 2. Email your capabilities statement or line card to the small business program office at CWI or PRC.**
- 3. Check online Forecast of Opportunities and submit an expression of interest for each specific opportunity using the link provided.**
- 4. Service Providers may also register in the CH2M HILL Contractor Qualification System (CQS) Online Interactive Database for exposure to all CH2M HILL affiliated companies.**
