DOE-OREM Partnership

- > Involvement
 - How best can we establish an effective working relationship?
- > Interaction
 - With DOE-OREM it is important that there be frequent interaction between the parties

 - DOE's attendance at the monthly Union Management Administrative Committee (UMAC) meetings shows its involvement in NABTU's matters and gives us the opportunity to understand the status of important DOE projects.







UCOR Partnership

- Open and frequent communication
 - Active and ongoing involvement by all levels of management with the workforce shows their concern for what is important to the workforce and that they want to work with us in an open format to address our concerns
- Open door policy
 - Management's openness with the workforce demonstrates to workers that they are heard and taken seriously
 - The result is higher morale, leading to safer behaviors and higher productivity
- High morale
 - Voluntary Protection Program (VPP)
 - Getting the Job Done Safely:
 - 2.9M square feet of buildings demolished
 - Over 36K loads sent to Environmental Management Waste Management Facility (EMWMF) without an accident
 - Over 208K cubic meters of nuclear waste disposed
 - Calendar Year 2015 total recordable case (TRC) rate 0.00 Lost Workday Away (LDWA) rate 0.00
 - Have worked over 2.8M hours without a LDWA







UCOR Partnership (cont.)

- Cooperative approach to resolving issues
 - No grievances since UCOR arrived
- Union Management Administrative Committee (UMAC)
- Cooperative Agreement of Labor and Management (CALM)
 - UCOR's active involvement with UMAC, CALM, sponsorship of the Tennessee Labor Management Foundation tells us we are important
- UCOR's active pursuit of the VPP STAR demonstrates to the workers that the highest premium is placed on making and keeping its operations safe so that all workers feel heard and appreciated in raising safety issues
