Hanford Central Plateau Remediation Site

Location: Hanford, Washington, USA

Value: \$5.8 billion

Project Scope

- Disposition of SNM, remediation, exhuming, and disposing of buried waste
- Decommissioning and Demolition of more than 800 facilities and structures
- 586-square mile Site is the U.S.'s largest environmental cleanup effort
- Remediation of contaminated environmental sites and groundwater

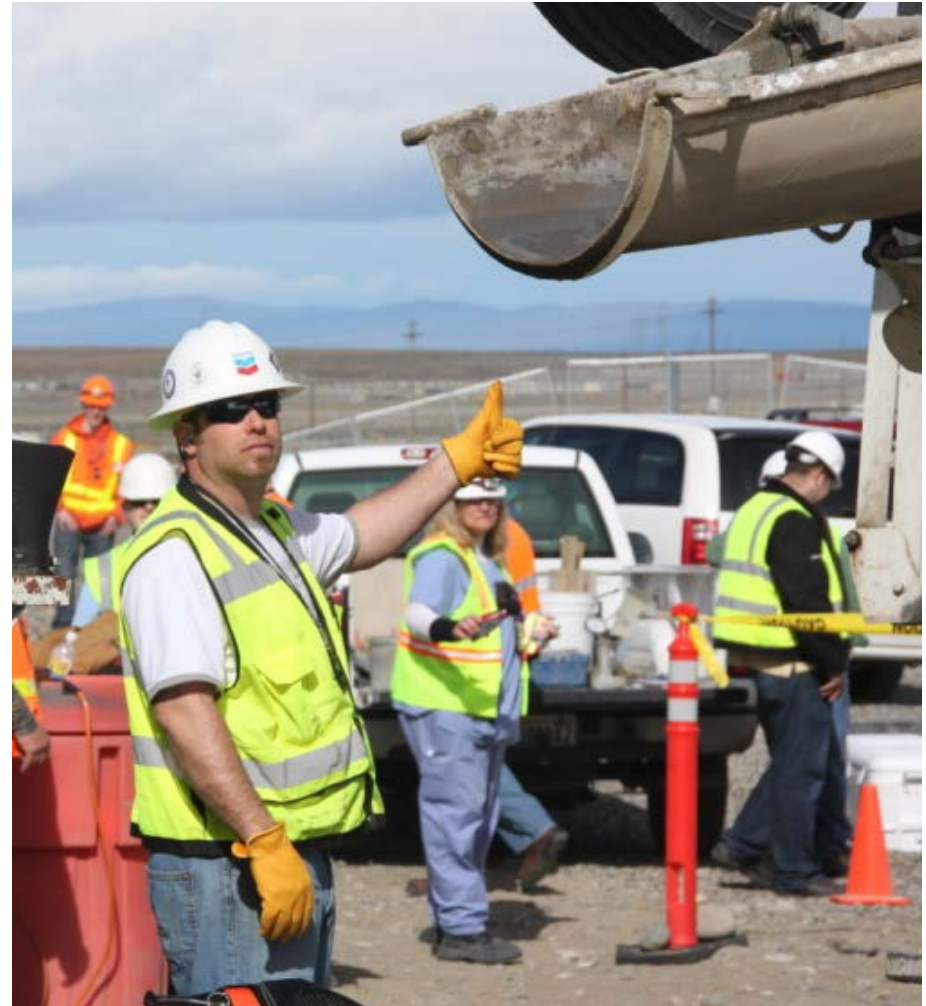
Our Role

- Prime contractor for the cleanup of hundreds of buildings and 1,200 waste sites
- Shrinking the Hanford Site cleanup area to less than 75 square miles by 2015 and further reduction to 10 square miles post-2015



Subcontracting at Hanford Central Plateau

- Since contract start in October 2008, \$2.17 billion has been subcontracted, with more than 50 percent, or \$1.09 billion, in awards to more than 460 small businesses.
- Expect to award more than \$230M between now and contract end in FY2018

Idaho Cleanup Project (ICP)

Location: Idaho Falls, Idaho, USA

Project Scope

The \$2.9 billion ICP-I was completed October 2012 - focused on reducing risks to workers, the public, and the environment and protecting the Snake River Plain Aquifer.

- Disposal and disposition of nuclear materials
- Management of spent nuclear fuel
- Closure of former high-level waste tanks
- Treatment and disposal of radioactive waste streams
- Cleanup of contaminated soil and water
- Demolition of high-risk and excess facilities
- Majority Partner



Idaho Cleanup Project (ICP-II)

- ICP-II contract runs 2013-2015 and includes
 - Sludge
 - Fuel Movements
 - Domestic receipts
 - CH TRU
 - IWTU
 - Tank closure
- Have not changed our strategy with regards to subcontracting during ICP-II contract
- Looking for suppliers who are sustainable, bio-based and environmentally friendly in order to meet sustainable requirements of contract
- Both CWI and ITG set to expire at end of FY 2015



Subcontracting at Idaho Cleanup Project

- Below is a breakdown of CH2M-WG Idaho's subcontracting dollars awarded from inception through February 22, 2015.

Steps to Initiating Business

- 1. Register your business in the Federal Contractor Registry (SAM) database. <http://federalcontractorregistry.com/>**
 - ◆ Ensure all fields are populated; key words, capabilities, references
 - ◆ Update profile frequently
- 2. Email your capabilities statement or line card to the small business program office at CWI or PRC.**
- 3. Check online Forecast of Opportunities and submit an expression of interest for each specific opportunity using the link provided.**
- 4. Service Providers may also register in the CH2M HILL Contractor Qualification System (CQS) Online Interactive Database for exposure to all CH2M HILL affiliated companies.**
