

What does it take to remain investment worthy?




- Understanding what needs to get done and a plan to achieve it

- Integrated Facilities Disposition Program (IFDP)
 - Identifies remaining environmental legacies on the Oak Ridge Reservation
 - Includes 80+ demolition and remediation projects and spans nearly three decades
 - Makes unneeded land/facilities available for economic development or growing missions in science and national security


Dollars in Millions
